**1. INTRODUCTION**

The purpose of this circular is to provide you with information in respect of certain resolutions to be proposed at the Annual General Meeting for (i) the re-election of the retiring

Directors; (ii) the granting to the Directors of the Share Repurchase Mandate and the Issuance Mandate.

### **2. PROPOSED RE-ELECTION OF RETIRING DIRECTORS**

Pursuant to the Articles, at each annual general meeting one-third of the Directors for the time being (or if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. A retiring Director shall be eligible for re-election.

In addition, any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election.

According to the Articles and in the opinion of the Board, Ms. Xie Qingmei, Mr. Lam Hin Chi and Prof. Jin Zhongwei shall retire at the Annual General Meeting. All of the above retiring Directors, being eligible, will offer themselves for re-election at the same meeting.

Details of the retiring Directors are set out in Appendix I to this circular.

### **3. PROPOSED SHARE REPURCHASE MANDATE AND ISSUANCE MANDATE**

By the shareholders' resolutions passed on 25 May 2018, general mandates were granted to the Directors to repurchase Shares and issue new Shares respectively. Such mandates will lapse at the conclusion of the Annual General Meeting. In order to give the Company the flexibility to repurchase Shares and issue new Shares if and when appropriate the following ordinary resolutions will be proposed at the Annual General Meeting to approve:

- (a) the granting of a general and unconditional mandate to the Directors to purchase Shares on the Stock Exchange of not exceeding 10% of the number of issued Shares of the Company as at the date of passing of the proposed ordinary resolution contained in item 4 of the notice of the Annual General Meeting as set out on page 14 of this circular (i.e. equivalent to 308,833,500 Shares on the basis that the number of issued Shares of the Company remains unchanged between the Latest Practicable Date and the date of the Annual General Meeting);
- (b) the granting of a general and unconditional mandate to the Directors to allot, issue or deal with additional Shares of not exceeding 20% of the number of issued Shares of the Company as at the date of passing of the proposed ordinary resolution contained in item 5 of the notice of the Annual General Meeting as set out on pages 14 to 15 of this circular (i.e. equivalent to 617,667,000 Shares on the basis that the number of issued Shares of the Company remains unchanged between the Latest Practicable Date and the date of the Annual General Meeting); and
- (c) the extension of the Issuance Mandate by adding thereto the aggregate number of Shares repurchased by the Company pursuant to the Share Repurchase Mandate.

## LETTER FROM THE BOARD

The Share Repurchase Mandate and the Issuance Mandate will expire:

- at the conclusion of the next annual general meeting of the Company;
- upon the expiration of the period within which the next annual general meeting of the Company is required by the Articles or any applicable laws of the Cayman Islands to be held; or
- when varied, revoked or renewed by an ordinary resolution of the Shareholders in a general meeting,

whichever is the earliest.

With reference to the Share Repurchase Mandate and the Issuance Mandate, the Directors wish to state that they have no immediate plan to repurchase any Shares or issue any new Shares pursuant thereto.

An explanatory statement required by the Listing Rules to provide you with requisite information reasonably necessary for you to make an informed decision on whether to vote for or against the granting of the Share Repurchase Mandate is set out in Appendix II to this circular.

#### **4. ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT**

The notice of the Annual General Meeting is set out on pages 13 to 16 of this circular.

Pursuant to Rule 13.39(4) of the Listing Rules and the Articles, any vote of shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates to purely a procedural or administrative matter to be voted on by a show of hands. An announcement on the poll results will be published by the Company after the Annual General Meeting in the manner prescribed under Rule 13.39(5) of the Listing Rules.

A form of proxy for use at the Annual General Meeting is enclosed with this circular and such form of proxy is also published on the websites of Hong Kong Exchanges and Clearing Limited (<http://www.hkexnews.hk>) and the Company (<http://www.merrygardenholdings.com>). To be valid, the form of proxy must be completed and signed in accordance with the instructions printed thereon and deposited, together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority at the Company's Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited, 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. Completion and delivery of the form of proxy will not preclude you from attending and voting at the Annual General Meeting if you so wish.

Accordingly, the Directors recommend the Shareholders to vote in favour of all resolutions to be proposed at the Annual General Meeting.

Pursuant to the Listing Rules, the details of the Directors, who will retire and offer themselves for re-election at the Annual General Meeting, are provided below.

**(1) Ms. Xie Qingmei (“Ms. Xie”)**

*Position, experience and relationship*

Xie Qingmei (謝清美), aged 51, was appointed as an executive Director on 15 June 2012 and as the Chairlady on 23 May 2016. Ms. Xie is primarily responsible for procurement matters in respect of the Group. She has over 15 years of experience in corporate management and procurement. Ms. Xie joined the Group in 1999, and she has been a deputy general manager of Zhangping Kimura since 2001 and a director of Zhangping Kimura since 2006. Ms. Xie was in charge of the sales department of Zhangping Kimura as well as supervising procurement from June 1999 to December 2000, and has been running the procurement department of Zhangping Kimura since 2003.

As far as the Directors are aware, Ms. Xie does not have any relationship with other Directors, senior management, substantial Shareholders or controlling Shareholders.

*Interests in Shares*

As far as the Directors are aware, as at the Latest Practicable Date, Ms. Xie was deemed to be interested in 9,633,380 Shares, representing 0.31% of the issued share capital of the Company.

Save as disclosed above and as far as the Directors are aware, as at the Latest Practicable Date, Ms. Xie was not interested or deemed to be interested in the Shares or the associated corporations of the Company pursuant to Part XV of the SFO.

*Length of service and Director’s emoluments*

Ms. Xie entered into a service contract with the Company on 15 June 2018 for a term of three years commencing from 15 June 2018, which may be terminated by not less than three months’ notice in writing served by either party on the other and is subject to termination provisions therein and provisions on retirement by rotation of Directors as set out in the Articles. Pursuant to the service contract, Mr. Xie is entitled to an annual salary of RMB144,000 and a discretionary bonus.

For the year ended 31 December 2018, the total emoluments paid to Ms. Xie was approximately RMB63,000 (including director fee, salaries, allowances and benefits in kind, discretionary bonus and retirement scheme contributions). The remuneration of Ms. Xie was determined with reference to the prevailing market conditions, Ms. Xie’s expertise, duties and responsibilities with the Company and the remuneration policy of the Group and is subject to review by the Company’s Remuneration Committee from time to time.

**(2) Mr. Lam Hin Chi (“Mr. Lam”)***Position, experience and relationship*

Lam Hin Chi (藍顯賜), aged 55, was appointed as an independent non-executive Director of the Company since 15 June 2012. Mr. Lam is a fellow member of The Association of Chartered Certified Accountants, and associates member of The Chartered Institute of Management Accountants, The Institute of Chartered Accountants in England and Wales and The Hong Kong Institute of Certified Public Accountants, respectively. Mr. Lam graduated from The Hong Kong Polytechnic University with a Professional Diploma in Management Accountancy and a Bachelor of Arts degree (Honours) in Accountancy. Mr. Lam has over 30 years of experience in finance, audit and accounting. Mr. Lam was a senior personnel of a number of companies listed on the Main Board of the Stock Exchange.

Mr. Lam is currently an independent non-executive director of VSTECS Holdings Limited (stock code: 856), which is listed on the Main Board of the Stock Exchange.

As far as the Directors are aware, Mr. Lam does not have any relationship with other Directors, senior management, substantial Shareholders or controlling Shareholders.

*Interests in Shares*

As far as the Directors are aware and as at the Latest Practicable Date, Mr. Lam was not interested or deemed to be interested in the Shares or the associated corporations of the Company pursuant to Part XV of the SFO.

*Length of service and Director’s emoluments*

Mr. Lam entered into a service contract with the Company on 15 June 2018 for a term of three years commencing from 15 June 2018, which may be terminated by not less than three months’ notice in writing served by either party on the other and is subject to termination provisions therein and provisions on retirement by rotation of Directors as set out in the Articles. Pursuant to the service contract, Mr. Lam is entitled to an annual salary of HK\$120,000 and a discretionary bonus.

For the year ended 31 December 2018, the total emoluments paid to Mr. Lam was approximately RMB102,000 (including director’s fee, salaries, allowances and benefits in kind and retirement scheme contributions). The remuneration of Mr. Lam was determined with reference to his duties and responsibilities with the Company, the prevailing market rate and the remuneration policy of the Group and is subject to review by the Company’s Remuneration Committee from time to time.

**(3) Professor Jin Zhongwei (“Professor Jin”)***Position, experience and relationship*

Professor Jin Zhongwei (金重為教授), aged 81, was appointed as an independent non-executive Director of the Company since 15 June 2012. He is an expert in wood preservation with over 40 years of experience in wood preservation. Professor Jin graduated from Nanjing Forestry College in 1961 and majored in forestry products chemical processing. He studied wood preservation and modification technologies in the United States as a government appointed scholar from 1981 to 1983, and was a visiting scholar at Oregon State University and Mississippi State University from 1994 to 1995 respectively.

As far as the Directors are aware, Professor Jin does not have any relationship with other Directors, senior management, substantial Shareholders or controlling Shareholders.

*Interests in Shares*

Save as disclosed above, as far as the Directors are aware, as at the Latest Practicable Date, Professor Jin was not interested or deemed to be interested in the Shares or the associated corporations of the Company pursuant to Part XV of the SFO.

*Length of service and Director’s emoluments*

Professor Jin entered into a service contract with the Company on 15 June 2018 for a term of three years commencing from 15 June 2018, which may be terminated by not less than three months’ notice in writing served by either party on the other and is subject to termination provisions therein and provisions on retirement by rotation of Directors as set out in the Articles. Pursuant to the service contract, Professor Jin is entitled to an annual salary of HK\$120,000.

For the year ended 31 December 2018, the total emoluments paid to Professor Jin was approximately RMB102,000 (including director’s fees, salaries, allowances, benefits in kind and retirement scheme contributions). The remuneration of Professor Jin was determined with reference to his duties and responsibilities with the Company, the prevailing market rate and the remuneration policy of the Group and is subject to review by the Company’s Remuneration Committee from time to time.

**(5) General**

Save as disclosed above, there are no other matters relating to the re-election of the retiring Directors that are required to be disclosed pursuant to any of the requirements of Rule 13.51(2) of the Listing Rules and no other matters need to be brought to the attention of the Shareholders.

The following is an explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the Annual General Meeting in relation to the granting of the Share Repurchase Mandate.

## **1. SHARE CAPITAL**

As at the Latest Practicable Date, the issued share capital of the Company comprised 3,088,335,000 Shares.

Subject to the passing of the ordinary resolution set out in item 4 of the notice of the Annual General Meeting in respect of the granting of the Share Repurchase Mandate and on the basis that the number of issued Shares of the Company remains unchanged between the Latest Practicable Date and the date of the Annual General Meeting i.e. being 3,088,335,000 Shares, the Directors would be authorised under the Share Repurchase Mandate to repurchase (during the period in which the Share Repurchase Mandate remains in force) a maximum of 308,833,500 Shares), representing 10% of the number of issued Shares as at the date of the Annual General Meeting.

## **2. REASONS FOR REPURCHASE OF SHARES**

The Directors believe that the granting of the Share Repurchase Mandate is in the best interests of the Company and the Shareholders.

Repurchases of Shares may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders.

## **3. FUNDING OF REPURCHASE**

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the memorandum of association of the Company and the Articles, the laws of the Cayman Islands and/or any other applicable laws, as the case may be.

## **4. IMPACT OF REPURCHASE**

There might be an impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2018) in the event that the Share Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not intend to exercise the Share Repurchase Mandate to such extent as would, in the circumstances, have an effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

**6. GENERAL**

To the best of their knowledge and having made all reasonable enquiries, none of the Directors nor any of their respective close associates (as defined in the Listing Rules) have any present intention to sell any Shares to the Company in the event that the granting of the Share Repurchase Mandate is approved by the Shareholders.

The Company has not been notified by any core connected persons (as defined in the Listing Rules) of the Company that they have a present intention to sell any Shares to the Company, or that they have undertaken not to sell any Shares held by them to the Company in the event that the granting of the Share Repurchase Mandate is approved by the Shareholders. The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchases of Shares pursuant to the Share Repurchase Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands.

**7. TAKEOVERS CODE**

If as a result of a repurchase of Shares pursuant to the Share Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of the Takeovers Code. Accordingly, a Shareholder or a group of Shareholders acting in concert (within the

meaning under the Takeovers Code), depending on the level of increase in the Shareholders' interest, could obtain or consolidate control of the Company and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

To the best knowledge of the Directors, as at the Latest Practicable Date:

Mr. Wu Zheyang and Green Seas Capital Limited, being parties acting in concert as defined under the Takeovers Code, were interested or deemed to be interested in 460,650,352 Shares representing 14.92% of the total issued share capital of the Company. In the event that the Directors exercise the proposed Share Repurchase Mandate in full, the interest or deemed interest in shareholding of Mr. Wu Zheyang and Green Seas Capital Limited would be increased to 16.57% of the total issued share capital of the Company which will not give rise to an obligation to make a mandatory offer under Rules 26 and 32 of the Takeovers Code.

Mr. Lin Jian, 福建沃若石油化工有限公司 and Hong Kong Run De Holdings Limited, being parties acting in concert as defined under the Takeovers Code, were interested or deemed to be interested in 430,000,000 Shares representing 13.92% of the total issued share capital of the Company. In the event that the Directors exercise the proposed Share Repurchase Mandate in full, the interest or deemed interest in shareholding of Mr. Lin Jian, 福建沃若石油化工有限公司 and Hong Kong Run De Holdings Limited would be increased to 15.47% of the total issued share capital of the Company which will not give rise to an obligation to make a mandatory offer under Rules 26 and 32 of the Takeovers Code.

Mr. Wang Xin, 上海荊勳工業設備控股有限公司 and Hong Kong Guoyuan Group Capital Holdings Limited, being parties acting in concert as defined under the Takeovers Code, were interested or deemed to be interested in 689,130,000 Shares representing 22.31% of the total issued share capital of the Company. In the event that the Directors exercise the proposed Share Repurchase Mandate in full, the interest or deemed interest in shareholding of Mr. Wang Xin, 上海荊勳工業設備控股有限公司 and Hong Kong Guoyuan Group Capital Holdings Limited would be increased to 24.79% of the total issued share capital of the Company which will not give rise to an obligation to make a mandatory offer under Rules 26 and 32 of the Takeovers Code.

The Directors do not consider such increase would reduce the issued share capital in the public to less than 25% (or the relevant prescribed minimum percentage required by the Stock Exchange). The Directors do not propose to exercise the Share Repurchase Mandate to such an extent that would result in the aggregate number of Shares held by the public Shareholders falling below the prescribed minimum percentage required by the Stock Exchange.
